## 1. Scope of Work

This includes trenching, hot tapping (with electrofusion saddle), electro fusion welding, pipe laying, back filling & restoration, GI Installation, Installation of Meter / Regulator / Isolation valve / rubber tube / Gas tap / other allied accessories, testing, nitrogen purging, commissioning and conversion of Domestic / Commercial PNG connection and, submission of as built drawing (Plotting service line in Main network drawing) for PE pipeline and Isometric drawing (Meter Job Card) of Domestic Installations duly accepted by OWNER / OWNER's representative.

### 6 Contract Value

- Total work order value is **Rs. 99,98,200/-** (Rs. Ninety Nine Lacs Ninety Eight Thousand Two Hundred Only). Unit rate for one Domestic PNG connection shall be Rs. 3,833/- (Rs. Three Thousand eight Hundred Thirty Three Only) as per details provided in the Schedule of Rates attached as **Annexure-1** to this work order.
- 6.2 The above mentioned Work Order Value is based on unit rate & payment shall be released based on actual quantum of work. Break-up of above Work Order value is provided in the Schedule of Rates attached as **Annexure-1** to this work order.
- Work Order value mentioned in clause 6.1 above is excluding Service tax & Sales tax as applicable but inclusive of all direct / indirect costs, expenses, insurance, liabilities of every description including all kinds of risks associated to complete the work. GSPC Gas shall not be liable to pay; any incidental or other cost incurred by the Contractor to complete the work, over and above Work Order value as defined. All payments under this contract shall be subject to income tax deduction i.e. Tax Deducted at Source (TDS) as may be applicable under the prevailing statute at the time of payment or its being due to the 'Contractor'.
